Dear LKC Families,

We want to welcome you to the Legacy Kids Care Program for the new school year. My name is Stephanie Lakosky, Assistant Principal, and I will be the program administrator for the before and after school program at the Northwest Tucson campus. We will have numerous instructors and support staff working LKC throughout the school year, most which have been a part of the program for many years.

I want to share a few important procedures and reminders with you as we begin a new year. LKC has a designated program number, 520-345-2024, which you can utilize during operation hours. Below is an outline of morning drop off, daily student procedures, and parent pick-up.

**Morning drop-off:**

LKC doors are open at 6:00am to begin receiving students. Below are the drop off procedures:

Parent escorts their child(ren) into the Computer/Library exterior door.

Parent is required to sign their child(ren) in before leaving to ensure all students are accounted for.

LKC staff member will greet families and available to answer any questions.

A.M. students are released at 7:30 when the school gates open for all students.

**After school transfer:**

Students who are enrolled in LKC for the P.M. session will be escorted by a designated grade level teacher, after All Call, to their designated area.

Students will be grouped into grade levels to ensure proper supervision and safety, such as K, 1, 2, 3-4, and 5-8. They will then have their afternoon snack (provided by the LKC program each day) and outdoor play. Students will return to their designated classroom to begin completing their homework assignments. After homework is completed, the groups will then begin open play.

**Pick-up:**

This year pick-up will be through our back gate and parking lot.

You must have your driveline sign for pick up. We have many programs, clubs, activities, and sports taking place on campus and we need to ensure the safety of all our students. Once you come through the back parking lot gate, you will find your child(ren) either on the playground or classroom.

Please provide the LKC staff the driveline sign and students name. Parents are required to sign their child(ren) out before they are released.

**Forms required:**

All students must have the required documents completed by Thursday, 8/3/17, which can be found attached, or on the LKC website. Click on the parent handbook to locate the forms.

**Payments:**

In regards to payments for LKC, please contact me if you have any questions or concerns and I will be happy to assist you in any way. Payments are calculated based upon the number of school days in the year. The annual enrollment fees are divided into ten equal monthly payments so that the monthly payments do not fluctuate. Monthly tuition does not include Day Camp or School Breaks.

For half days we will be providing lunch, a snack, and structured activities, similar to the regular center schedule. On holidays and breaks, we will keep you updated regarding the schedule and availability.
